Minute 2429 Planning

1. DC/2010/00253 Brook Acre, Earlswood

Change of use of existing dwelling house to four placement children's home

A large number of residents attended the meeting with the vast majority opposed to the application. Three people representing Care UK also attended the meeting. The residents had elected a speaker to put forward their objections (see attached) Care UK responded to the objections and also answered questions from the floor and from Cllrs. It was apparent that there was grave concern amongst the residents.

Recommend refusal by a majority vote for the following reasons

- H11 (b) UDP states 'Adequate space around the home is provided (separate from car park areas) to ensure that the amenity of neighbouring properties is protected and that sufficient amenity space is available for residents of the home' This property is not isolated as indicated in the application and there is inadequate space surrounding the property to entertain children
- H11(c) UDP states 'The facilities are located to allow full, easy and safe access for disabled people and elderly people' -The split level design does not comply with regulations for disabled access and provision for such access is not included in the application
- <u>H11 (d) UDP states 'The development is located within easy reach of public transport facilities'</u> public transport only passes a mile away hourly in each direction on weekdays. No transport at all on Sundays and bank Holidays.
- Planning Wales states The courts have held that perceived fears of the public are a material planning consideration that should be taken into account in determining whether a proposed development would affect the amenity of an area. There is a real public fear about the possible consequences of housing troubled children
- Other concerns raised

School too far away - two hours travelling daily

Lack of local facilities to entertain children

Shoot being established across the brook which could possibly endanger children

Lack of employment for local people in this business opportunity

Formation of conservatory over garage

Recommend approval

3. DC/2010/00167 Latimer Farm, Earlswood

New agricultural livestock and storage building (revision of M/6268)

Recommend refusal

- Building is too large for proposed use size and design looks more suitable for a house than an agricultural building
- Proposed building is to provide accommodation for up to 12 suckler cows but there is no mention of waste disposal, water or electricity in the application.
- No detail about environmental impact e.g. slurry
- Height may possibly be greater than the cottage

N.B. We would draw attention to the clause in previous application M/6268 i.e. this building should not be converted to a dwelling in the future.

Minute 2432 Items of local concern - information only

A reminder was given to Cllrs of the importance of concerned residents attending the Planning Appeal for affordable houses that will be held in the Church hall on May 20th.

Mynders Cottage. Considerable concern has been expressed about the excavations at Mynders Cottage and especially about the amount of hedgerow that has been ripped out. Enforcement and Countryside departments will look into this.

Concern was also expressed about the timing of this i.e during the nesting season. Cllr Leaf agreed to discuss this with the Environment Agency

Problems had arisen because when the main road was resurfaced and the roll over at the entrance to the car park was removed and not replaced. This allowed excess rainwater coming down the road to enter the Car Park
